# Vaccine Administration in Long-Term Care and Retirement Homes January-December 2024

**To:** Board of Health

**Key Points** 

- The 2024 Fall Vaccine Campaign successfully provided Influenza, COVID-19, and RSV vaccines to Long-Term Care Homes (LTCHs) and Retirement Homes (RHs).
- Influenza vaccination rates remain high, protecting our residents during this Influenza season.
- Compared to 2023, the COVID-19 vaccine uptake saw slight improvement in some homes but remains lower overall compared to Influenza vaccination rates.
- RSV vaccination had a variable uptake, with leading homes reaching over 90% coverage while others remain lower. Many LTCH residents did not require an RSV vaccine this year as they received one in the 2023 campaign.
- Public Health continues to play a key role in vaccine coordination, working closely with pharmacies, family doctors, and facility staff to streamline vaccine administration.
- A comprehensive debriefing process with each home will be conducted to assess successes and opportunities for improvement, focusing on facilities with lower vaccination rates.

# **Highlights**

#### 1. Influenza:

Influenza vaccine uptake remained strong in 2024, averaging **80% in LTCHs** and **85% in RHs**, relatively consistent with the previous year (*See Figure 1*). Most homes maintained or improved coverage, ensuring high protection before peak respiratory season (see Appendix A).

#### 2. COVID-19:

COVID-19 vaccination uptake in 2024 averaged **71% in RHs** and **67% in LTCHs**, slightly down from 74% and 75% in 2023, remaining below the 90% goal(see Appendix B). Vaccine fatigue seemed to contribute to the decline in uptake; however, targeted engagement helped stabilize numbers, underscoring the need for continued public health interventions to promote vaccination. Vaccine fatigue, though targeted engagement helped stabilize numbers highlighting the importance of continued public health interventions to promote vaccination. The Preliminary provincial averages for this season's COVID-19 vaccine rates are **54.5% in LTCH** and **50.5% in RHs** showcasing WDGPH is well above the provincial average.

#### 3. RSV:

The RSV vaccine is expected to provide longer protection so does not require an annual vaccine. Many LTCH residents did not require a RSV dose this year due to a successful 2023 campaign run in the LTCHs. The first launch of RSV vaccine in the RHs had a varied uptake (see Figure 2 and Appendix C). Overall, the first-year rollout in the RHs was successful, with optimism for higher uptake in the future.

#### **Key Factors Contributing to Success**

- Early access to vaccines ensured clinics were completed ahead of peak respiratory illness season, providing better protection for residents. The majority of homes launched their campaigns before October 2, 2024.
- Enhanced support and education through targeted outreach, education sessions, and one-on-one planning support improved vaccine coordination and uptake.
- Local pharmacies and family doctors collaborated with Long-Term Care Homes (LTCH) and Retirement Homes (RH) to streamline the vaccine administration process, with encouragement and support from WDG Public Health as needed. These strong community partnerships helped alleviate the burden on LTCH and RH staff.

#### Takeaways for the 2025 Campaign

WDG Public Health conducted an in-depth evaluation of the 2024 vaccination campaign taking an evidence-based approach to guide and enhance effectiveness of future outreach initiatives.

#### **Educational Support & Resources**

- Increased interest in physical educational handouts and fact sheets highlights the need to focus on more accessible vaccine information for both residents and staff.
- In-service training sessions from the Infection Control team, and Medical Officer of Health information briefings received strong praise, with recommendations to expand outreach efforts to maximize impact.

#### Vaccine Administration & Coordination

- While some homes reported smooth and efficient vaccine rollouts, others emphasized the need for more in-person vaccine promotion, particularly in retirement home settings.
- Many facilities cited collaborations with pharmacies as a key factor in streamlining vaccine administration and improving accessibility given their limited resources.

#### Staff Engagement & Uptake

Difficulty in monitoring staff vaccination rates remains a concern, as some employees
opt not to disclose their status, complicating reporting efforts. Homes are requested to track
HCW vaccination and report the data to the Ministry of Health however, not all staff report their
Influenza vaccine to their home leading to under reporting. Rates may be higher than shown in
Appendix D. (Appendix A)

The 2024 campaign was widely regarded as well-executed, with overwhelming appreciation for the support provided by WDG Public Health. Minor recommendations for enhancing communication and optimizing resource distribution will be incorporated into planning for the 2025 campaign, ensuring even greater efficiency and engagement.



#### **Next Steps**

- **Post-Campaign Debriefs:** Conduct structured sessions with each home to assess successes, challenges, and areas for improvement in 2025.
- Targeted Engagement for Lower-Uptake Homes: Provide tailored education, inperson outreach, and clearer communication on RSV and COVID-19 vaccine benefits.
- Enhancing Communication on Booster Timing: Clarify messaging to address vaccine fatigue, improve scheduling, and align boosters with prior vaccinations.
- **Expanding Educational Resources:** Increase availability of fact sheets, handouts, and digital materials to enhance vaccine literacy.
- **Strengthening Pharmacy Partnerships:** Continue leveraging pharmacies for efficient vaccine administration and explore expanding partnerships.
