#### **Highlights**

The Control of Infectious Diseases (CID) Team presented the *Clean, Wrapped, and Loaded* Workshop at the Infection Prevention and Control Canada (IPAC) Conference and the Canadian Institute of Public Health Inspectors (CIPHI) National Conference. The CID Team completed all required Personal Service Setting inspections in 2019.

Rabies continues to be a disease of public health significance and success has been achieved by maintaining a low percentage of animal exposure victims who required post-exposure rabies prophylaxis, through risk assessment and consultations with healthcare professionals. Low-cost rabies pet vaccination clinics were delivered in Ospringe, Orangeville and Grand Valley.
