Subject: LEASED SPACE IN MOUNT FOREST AND GUELPH (SHELLDALE)

UPDATE

RECOMMENDATION(S):

(a) That the Finance & Facilities Committee makes recommendation to the Board of Health to receive this report for information.

BACKGROUND:

In September 2017, the Facilities Committee of the Board of Health reviewed Finance Committee Report BH.03.SEP1517.R01 - Leased Space in Mount Forest and Guelph (Shelldale).

Wellington-Dufferin-Guelph Public Health (WDGPH) Management advised the Lessor at 20 Shelldale Crescent, in Guelph, of WDGPH's intention to vacate on June 30, 2018. Management advised the Lessor at 355 Durham Street West, Mount Forest Park of WDGPH's intent to vacate on November 30, 2018.

PUBLIC HEALTH AND/OR FINANCIAL IMPLICATIONS:

These changes will provide for the re-deployment of these funds to other services and program work in achievement of the Public Health Standards.

Direct saving calculated based on the 2018 budget year are:

- Shelldale annual savings \$97,052; and
- Mount Forest annual savings \$53,298.

Indirect savings include:

- Reduced obligation under the *Occupational Health and Safety Act*, the expectation for a safe workplace with less office locations. Staff and management time involved to ensure a safe workplace is maintained will be recovered.
- There will be a reduction in facilities maintenance tasks that are WDGPH's responsibility within the lease including: contractor management; general site service; and maintenance.
- Reduction in Management staff responsibility for after-hours on-call security matters at these
 locations. The mileage and staff time, which is not captured here, to attend to these matters
 relative to the overall space utilization and service provision levels, increase the overall cost of
 each of these locations.

Shelldale:

The leased space at Shelldale ends effective June 30, 2018. Staff in all affected program areas have been working to plan for the exit, communicating this to both partners and clients. This communication includes the location of the services going forward. The details of this are found in Appendix "A".

Mount Forest:

The leased space at Mount Forest ends effective November 30, 2018. Staff in all affected program areas have been working to plan for the exit with some communication to both partners and clients. As this move is still a number of months away, some details are still being finalized. The details as we know now are found in Appendix "B".

WDGPH staff continue to work with community partners to ensure clients have access to required services and are communicating service changes as they are confirmed.
