## Provincial School Rapid Antigen Testing Program

The Government of Ontario has announced that rapid COVID-19 antigen tests will be made available for targeted testing of children in schools and registered childcare settings. WDG Public Health will participate in this program. ## Further Protection for Long-Term Care Residents and Staff

Ontario is taking further action to protect long-term care residents and staff. COVID-19 vaccinations will become mandatory for all in-home staff, support workers, students, and volunteers by November 15, 2021, unless they have a valid medical exemption. Inspections of homes are being expanded and provincial resources redirected to enhance and audit existing testing in homes. ## **Announcements and Changes to Services**

- On October 6, the <u>Government of Ontario</u> announced it will provide up to \$270 million this year to long-term care homes to increase staffing levels by 4,050 new long-term care staff across the province, leading to more direct care for residents.
- On October 6, <u>the Prime Minister, Justin Trudeau</u> announced details of the plans to require COVID-19 vaccination across the federal public service and federally regulated transportation sectors.
- On October 5, the <u>Government of Ontario</u> announced it is providing more than \$46 million to support 648 non-profit tourism, culture, sport and recreation organizations experiencing significant financial pressures due to COVID-19.



 On September 29, <u>Dr. Kieran Moore, Chief Medical Officer of Health</u> announced that Ontario has issued a preferential recommendation of the use of Pfizer-BioNTech vaccine for individuals aged 18-24 years old effective immediately based on the current available analysis from Ontario's adverse events following immunization (AEFI) surveillance system.
