## Cannabis (Update)

• Dr. Mercer spoke to the April 2019 Edition of Cannabis Facts entitled "Cannabis and Children: A growing need to prevent harm" as follows: (1) There is no known safe amount of cannabis during pregnancy and breastfeeding; (2) Cannabis should be kept locked up and out of reach of children; (3) Cannabis impairment can affect parenting and driving; (4) Second hand cannabis smoke is harmful; and (5) Parenting approaches can help prevent or delay youth cannabis use.
