Dr. Mercer provided an update as follows:

• Dr. Mercer highlights the 2023 Wellington-Dufferin-Guelph Public Health (WDGPH) Cannabis Survey that is available via the Agency's <u>website</u>. By completing the survey there is a chance to win \$100.

- An update is provided regarding ticks in Wellington-Dufferin-Guelph (WDG) and Ontario. Climate change is responsible for an increase in ticks, with milder winters in Canada, there is a significant decrease in the overwintering mortality of black-legged ticks.
- Important to note that Public Health is longer accepting tick submissions from the public.
- For more information on tick prevention and instructions for proper method of removal, please visit the WDGPH website page related to the same.
- A video on our website illustrating the proper removal method for removing ticks was suggested by a Board member and Dr. Mercer agreed that this was a good idea and would be added.
- An air quality update was provided given the wildfires occurring across the country.
- Symptoms that may occur while the Air Quality Health Index (AQHI) is higher were discussed. Seniors, young children, pregnant individuals as well as smokers and asthmatics should take extra care.

BH.01.JUN0723.R19 - Healthy Babies Healthy Children Program

- The Healthy Babies Healthy Children Program (HBHC) is a mandated program funded by the Ministry of Children, Community and Social Services (MCCSS).
- The program was restarted in 2022 and since then 2309 home visits have been conducted.
- New and innovative practices are being developed and deployed such as iPads for home visits and an SMS system to text clients.

- The outreach to hospitals and community partners has been restarted and conversations are ongoing.
- Ongoing program review and evaluation will help to provide further program innovation and efficiencies to provide the public with quality program delivery.

BH.01.JUN0723.R20 - Injury Surveillance and Prevention Report

- This report provides an overview of the injury related emergency department visits, hospitalizations, and mortality information for the Wellington-Dufferin-Guelph (WDG) region by geography, age group and sex.
- Unintentional injuries were the leading cause of death in Canadians aged 1-34 resulting in a significant burden of disability and long-term effects.
- WDGPH works closely with its community partners to reduce the burden of preventable injuries through data analysis, research evidence and evaluation support.
- The Agency strives to provide relevant data for its municipal partners to enable them to make meaningful, informed decisions.
