4.0 MOH Updates

MOH Update(s):

Dr. Mercer provided several updates as follows:

- National Truth and Reconciliation Day is on September 30, 2024. Dr. Mercer encouraged staff to set aside time to reflect and consider how they can continue to promote the work of reconciliation with indigenous communities.
- International Literacy Day is on September 8, 2024, this year. The day promotes the importance of literacy as a matter of dignity and human rights. The importance of language development and literacy skills in early childhood was highlighted.
- WDGPH has launched a Community Alcohol Survey over the summer months to learn more about the community's current knowledge, attitudes and behaviours related to alcohol. Residents of WDG are eligible to participate and participation automatically enters individuals into a draw for a chance to win a \$100 gift card. Details are provided on WDGPH's website.
- WDGPH will provide a Stigma training session to Board of Health members in the coming months. The Board members discussed appropriate timing and R. Isley, WDGPH's Chief Nursing Officer, will be following up with her team to schedule a date and time.

8.0 BOH Report(s)

BH.01.SEP0424.R25 – 2024 WHY Surveys

Dr. Mercer introduced and L. Dossett presented on screen and reviewed the contents of BOH Report BH.01.SEP0424.R25– as follows:

- The WHY Surveys collect valuable self-reported health and well-being data from students, parents, and school-board staff across WDG.
- The results of these surveys create a shared understanding of students' well-being and help to identify challenges facing local youth.
- This is the third cycle of WHY Surveys, collected between November 2023 and February 2024. The first and second cycles were collected in 2019 and 2022 respectively.
- The results of the WHY Surveys provide WDGPH with valuable insights and aids in developing comprehensive strategies to support the physical, mental, and social wellbeing of children in the WDG community.

BH.01.SEP0424.R26 - Youth Gambling, Gaming, and Substance Use Prevention Program

Dr. Mercer introduced and A. Vanderlaan presented on screen and reviewed the contents of BOH Report BH.01.SEP0424.R26 – as follows:

- Increasing rates have been observed in youth across the WDG region concerning potentially harmful and addictive behaviours such as gambling, gaming, and substance use.
- WDGPH has been working with and supporting the work of its community partners in their efforts to combat this issue.
- WDPGH conducted a survey of the gambling, gaming, and substance use prevention and education program developed by Homewood Health in partnership with UGDSB and WCDSB. The students recognized the importance of the program, but also provided recommendations for improvement.
- A. Vanderlaan shared the evaluation results with the Board. The results will be incorporated into future program planning.

BH.01.SEP0424.R27 – School-Based Immunization Program: A Focus on HPV

Dr. Mercer introduced and K. Mulvey presented on screen and reviewed the contents of BOH Report BH.01.SEP0424.R27 – as follows:

- Each year, WDGPH offers the hepatitis B, human papillomavirus (HPV), and quadrivalent meningococcal conjugate (MCV4) vaccines to students in WDG as part of the provincial school immunization program. The uptake for these vaccines in the WDG area is above the provincial average for 12 and 17-year-olds, however the HPV vaccine continues to have a lower immunization coverage rate across all grades.
- K. Mulvey highlighted the success of the HPV vaccine, which has been scientifically proven to prevent several different types of HPV infections and related cancers.
- Beginning in September, parents and guardians of grade 7 students will receive online consent forms and information packages from WDGPH regarding school vaccine clinics.
- It is strongly recommended that all children receive these vaccines to safeguard them against future cancers.

BH.01.SEP0424.R28 – Opioid Surveillance Update

Dr. Mercer introduced and J. MacKinlay reviewed the contents of BOH Report BH.01.SEP0424.R28 – as follows:

- The City of Guelph and Dufferin County have recently witnessed increases in opioid-related emergency department visits, while Wellington county witnessed a slight decrease.
- As of 2023, WDG's rates of opioid-related mortality have gradually declined. WDG's opioid-related mortality rates are 32% below the provincial average.
- WDGPH's FAST Surveillance System has been updated to include EMS data, extending its coverage to the entirety of the WDG region.
- WDGPH will continue to collaborate with its community partners to develop a multi-disciplinary and community-wide response to the opioid crises.

• Board members discussed current and future state funding for treatment centres and safe consumption sites.
