In order to attend school, the Immunization of School Pupils Act, 1990 (ISPA), requires students be vaccinated against the following diseases:

• Diptheria

- Pertussis
- Measles

 Tetanus Polio

- Rubella
- •
- Mumps
- Meningococcal disease Varicella (born 2010 or later)

Each year, Wellington-Dufferin-Guelph Public Health (WDGPH) reviews student immunization records and notifies parents/guardians and students if their vaccinations are overdue. At this time, approximately 12,000 elementary and high school students across Wellington-Dufferin-Guelph are overdue for required vaccines, according to WDGPH records. Students who have not received all required vaccines may be suspended from school.

# **Notification for Required Vaccines**

Vaccine notices will start to be mailed to high school students in January, followed by elementary students in February through March.

All parents/guardians in the WDGPH area will be notified if their child(ren) are overdue for doses of vaccines that are required under the ISPA to attend school. This notification will provide information on what vaccine(s) are missing and the steps that families can take to get immunized, submit vaccine records to WDGPH, or obtain a valid exemption.

# Notification for Recommended Vaccines

In addition to the vaccine notices, WDGPH will be sending a separate letter to advise parents/guardians and students if they are eligible for any part of their vaccine series for Hepatitis B (HB), Human Papillomavirus (HPV) and Varicella vaccine (if born before 2010). This letter will recommend that students receive these vaccines but will note that they are not required to attend school.

# **Options for Students to get Immunized**

WDGPH is currently providing school-based clinics in all elementary schools to offer vaccines under the grade 7 immunization program for HB, HPV and Meningococcal disease. High School clinics will be starting in February 2023 and will offer all vaccines required to attend school as well as the HB, HPV, or varicella vaccine. All routine vaccines are also offered in all three public health offices. More information can be found <u>on our website</u>.

Students may also present at their primary care practitioner's office with the two notices listed above for required and recommended vaccines. Samples of each notice are attached.

## **Ordering Vaccine**

#### **Reporting Vaccinations to Public Health**

## Exemptions

Children who cannot be immunized for medical reasons need to have a <u>Statement of Medical</u> <u>Exemption</u> completed by their physician and submitted to Public Health. If parents are choosing not to immunize children for religious or conscientious reasons, there are other steps that they need to follow. ## **Routine Immunizations and the COVID-19 Vaccine**

The National Advisory Committee on Immunization (NACI) recommends that the COVID-19 vaccine may be given concomitantly with, or at any time before or after, other vaccines<sup>1.</sup> The risk of vaccine preventable diseases outweighs the risk of rare adverse events following immunization and delayed vaccine doses should be offered at the earliest opportunity.<sup>2</sup> If a child is overdue for a COVID-19 vaccine dose, please consider offering this at the same visit.
