Pharmacy and Primary Care offering Astra Zeneca:

- Pharmacists and primary care providers offering the AstraZeneca vaccine need to inform each
 patient of their expected second dose interval and ensure the patient has a second dose
 appointment booked.
- All second dose appointments for AstraZeneca should be booked following the recommended second dose intervals defined below.
- For your patients who have received an mRNA vaccine at a WDGPH mass vaccine clinic,
 WDGPH will follow up directly with the patient and book their second dose appointment.

Recommended Second Dose Intervals:

Vaccine	Standard second dose interval	Second dose interval exceptions
Pfizer	16 weeks	26 days
Moderna	16 weeks	26 days
AstraZeneca	16 weeks	12 weeks

Second Dose Interval Exceptions:

There are a limited number of exceptions to the standard, 16-week interval between the first and second vaccine dose. Second dose exceptions do NOT include the patient's essential caregiver. The ONLY exceptions are:

- Patients on stable, active treatment (chemotherapy, targeted therapy, immunotherapy) for malignant hematologic disorders or nonhematologic malignant solid tumors
- Transplant recipients (including solid organ transplants and hematopoietic stem cell transplants)¹

For multiple patients, you may submit a list directly from your EMR. Please include:

- Name and contact information for each patient
- Reason for referral
- Contact name and number for the referring the health care provider for follow up
- Indicate "For Second Dose Exception"
