COVID-19 Vaccine Interchangeability

Following the emerging evidence on the risk of vaccine-induced immune thrombotic thrombocytopenia (VITT) associated with the use of viral vector vaccines, the Public Health Agency asked National Advisory Committee on Immunizations (NACI) to provide recommendations on the use of a mixed two-dose primary series schedule for COVID-19 immunization. NACI conducted a review of the evidence on the safety and immunogenicity of mixed schedules of mRNA and viral vector COVID-19 vaccines and provided two recommendations on vaccine interchangeability:

- NACI recommends when the first dose is an <u>mRNA COVID-19 vaccine</u> (Pfizer or Moderna), the same mRNA COVID-19 vaccine product should be offered for the second dose. However, when the same mRNA COVID-19 vaccine produce is not readily available, or is unknown, another mRNA COVID-19 vaccine product recommended for use in that age group can be considered interchangeable and should be offered to complete the vaccine series. The previous dose should be counted, and the series need not be restarted.
- NACI recommends when the first dose is the <u>AstraZeneca/COVISHIELD COVID-19</u>
 <u>vaccine</u> that either AstraZeneca/COVISHIELD <u>OR</u> an mRNA COVID-19 vaccine (Pfizer or Moderna) may be offered for the subsequent dose in a vaccine series. The previous dose should be counted, and the series need not be restarted.¹

Official recommendations for Ontario are pending.

Prioritization for Second Doses - May to August 2021

Ontario has already begun prioritizing second doses to certain groups including individuals with certain health conditions,² high-risk health care workers,³ and First Nations, Inuit and Metis individuals.

Table 1: Prioritization for Second Doses - May to August 2021⁴

Type of Vaccine	Eligibility Criteria
AstraZeneca/ COVISHIELD	At least 12 weeks have passed since the individual's first dose
Pfizer-BioNTech and Moderna	 As of May 31, 2021 Individuals who are 80 years of age or older; AND At least 4 weeks have passed since the first dose. As of June 14, 2021 Individuals who are 70 years of age or older; AND
	 At least 4 weeks have passed since the first dose. As of June 28, 2021 Individuals who received their first dose during the period of March 8 to April 18, 2021
	As of July 19, 2021 Individuals who received their first dose during the period of April 19 to May 9, 2021
	 As of August 2, 2021 Individuals who received their first dose during the period of May 10 to May 30, 2021
	 As of August 9, 2021 All other individuals who received their first dose from May 31 onwards; AND At least 4 weeks have passed since the first dose.
